
## **Notification**

**(Pertaining to admission in Two Year D.El.Ed Course, Session - 2023-2025)**

In continuation of our earlier Principal Notifications vide No. **195/WBBPE/D.El.Ed./2024/33A-08/2023** dated **13/03/2024** and subsequent notifications issued from time to time including admission guidelines, it is further to notify for all the heads of the D. El. Ed. Institutions affiliated to WBBPE and recognised by NCTE that upon considering the prayers submitted by the different D. El. Ed. institutions for rectification/correction and admission in the unfilled vacant seats and after proper verification of online application status of the students in the institute log-in for admission in the course, session 2023-2025 it is decided by the WBBPE for the interest of candidates, who are in the master list of the institutes and intending to pursue the training programme :

1. The Heads of the D. El. Ed. Institutions are requested to submit the prayers/applications for admission to the seats vacated due to left out/discontinuation of the earlier admitted candidates. The supporting documents/undertaking in this regard should be attached with prayers/applications.
2. They are instructed to submit the prayers for rectification of rejected valid applications during online scrutiny/admission, due to technical reasons.
3. They are also requested to submit the prayers for admission in the unfilled vacant seats of the institutes from the candidates present in the waiting list having valid application ID of the candidates.

All such rectifications/corrections will be permitted by the competent authority of the WBBPE on submitting a processing fee @ Rs. 3000/- (Rupees three thousand) only per candidate through online payment mode to be available at the institute log-in during rectification on strict adherence of the timeline, i.e. on and from 23/04/2024 to 27/04/2024. In no circumstances, further prayers in this regard will be entertained by the Board.
